#### **GENERAL INFORMATION**

- Google Chrome is the preferred browser.
  - Assure latest version of Google Chrome is being used and third-party cookies and popups are enabled for the time you are completing the training. Do not use a Private or Incognito browsing window.
- Course completion time may be monitored and failure to demonstrate a sufficient amount of time spent completing the course could result in corrective action.
- If you begin the training and need to stop and return to it later, you should complete the section you are working on before logging out.
- The final step required to record your training completion is the statement of completion. Placing a checkmark in the checkbox next to the "I certify" statement and selecting the checkmark button on the last slide in the training finalizes training completion and generates the award certificate. You <u>MUST</u> complete this step to receive credit.
- Once you have completed the training, you should receive an email prompting you to print your completion certificate. This notice may take at least 15 minutes to appear.
